Ignitable Liquids Reference Collection (ILRC)

Sample Ordering Procedures

Forensic laboratories can use the order form on the reverse side to purchase samples of ignitable liquids listed in the ILRC database: www.ncfs.org/databases. Samples will be shipped in 1/2 dram vials on activated charcoal. Orders for neat liquids may be filled by special request for an additional charge. Completed order forms can be sent to the Center via fax, mail, or email.

Payment Policy

Sample cost is \$5.00/sample plus \$ 7.50/shipment for shipping and handling to destinations in the continental US, \$8.00/shipment to Alaska and Hawaii. Contact the Center for shipments to Canada and other international destinations. Payment must be in the form of check or purchase order payable to: University of Central Florida.

Shipping Policy

All orders are shipped via UPS-Ground. Orders will be filled within one week of receipt of payment. In transit delivery times for UPS-Ground from Orlando vary from one to seven days. Material Safety Data Sheets (MSDS) are available in the ILRC database.
